Trading Mate Privacy Policy

Trading Mate Pty Ltd ACN 165 606 459 (referred to as **Trading Mate**, **we**, **us** or **our**) has implemented this Privacy Policy to provide users (referred to as **Members**, **you** or **your**) with information about how we collect, hold and use Personal Information on the Trading Mate website www.tradingmate.com.au (**TradingMate.com.au**) and generally. We are committed to the protection of your Personal Information in accordance with the Privacy Act 1988(Cth), specifically The Australian Privacy Principles (APPs), which came into force on 12 March 2014.

We may, from time to time, review and update this Privacy Policy including, and to take into account new laws, regulations and technology. All Personal Information held by us will be governed by our most recent Privacy Policy, posted on TradingMate.com.au.

1. What is "Personal Information"?

"**Personal Information**" is information or an opinion, whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent, or can reasonably be ascertained. Personal Information collected may include (but is not limited to) the following:

- (a) Name, postal, billing, email and social media addresses;
- (b) contact details including telephone numbers (landline, mobile and fax); and
- (c) payment details excluding credit card information (no credit card information is stored by Trading Mate Pty Ltd).

2. When and why we collect Personal Information

- 2.1 We collect your Personal Information to manage our ongoing relationship with you and perform functions and activities relating to our business
- 2.2 We may collect Personal Information such as your name, email contact details, billing and delivery addresses, and payment details (no credit card information is stored by Trading Mate Pty Ltd) when you:
- (a) Create a Member account on TradingMate.com.au;
- (b) access and use TradingMate.com.au;
- (c) request information about us, our services or a product;
- (d) request technical support or assistance;
- (e) provide feedback or to make new product/service requests;
- (f) subscribe to our newsletter;
- (g) fill in a form on TradingMate.com.au;
- (h) contact us by telephone, email, through social media, by post or in person; or
- (I) submit a resume (whether unsolicited or not) when you apply for an employee position with us.

3. Information collected via TradingMate.com.au

3.1 We will not collect any Personal Information about users of TradingMate.com.au except when they knowingly provide it or as otherwise described below.

Click Stream Data

3.2 When you visit and browse TradingMate.com.au, our TradingMate.com.au host may collect information for statistical, reporting and maintenance purposes.

- 3.3 Subject to clause 6.3 of the Privacy Policy, the information collected by our TradingMate.com.au host will not be used to identify you. The information may include:
- (a) The number of users visiting TradingMate.com.au and the number of pages viewed;
- (b) the date, time and duration of a visit;
- (c) the IP address of your computer; or
- (d) the path taken through TradingMate.com.au.
- 3.4 Our TradingMate.com.au host uses this information to administer and improve the performance of TradingMate.com.au.
- 3.5 We use Google Analytics to help analyze how you use TradingMate.com.au. Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users' computers. The information generated is used to create reports about the use of TradingMate.com.au. Google will store this information. We will not (and will not allow any third party to) use Google Analytics to track or to collect any personally identifiable information of visitors to TradingMate.com.au. We will not associate any data gathered from TradingMate.com.au with any personally identifying information from any source as part of our use of Google Analytics.
- 3.6 If you do not want your website visit data reported by Google Analytics, you can install the Google Analytics opt-out browser add-on. For more details on installing and uninstalling the add-on, please visit the Google Analytics opt-out page at https://tools.google.com/dlpage/gaoptout.

Cookies

- 3.7 Cookies are small text files that are transferred to a user's computer hard drive by a website for the purpose of storing information about a user's identity, browser type or website visiting patterns. Cookies may be either "persistent" or "session" cookies. A persistent cookie will be stored on the user's computer and will remain valid until its set expiry date, unless deleted by the user before then. A session cookie, on the other hand, will expire at the end of the user session, when the internet browser is closed.
- 3.8 If you access TradingMate.com.au, a cookie is downloaded onto your computer's hard drive when you first log on to TradingMate.com.au. TradingMate.com.au uses session cookies but also persistent cookies for Google Analytics.
- 3.9 You can adjust your internet browser to disable cookies, or you can delete cookies already stored on your computer, however we may not be able to provide you with all the service or functionality you require on TradingMate.com.au if you choose to do so.

4. How we use the Personal Information we collect about you

- 4.1 We use the Personal Information we collect about you for our business functions and activities, which may include the following:
- (a) To communicate with you and provide you with information, products or services you have requested;
- (b) to manage and administer your account in relation to all information uploaded by you;
- (c) to promote and market our products and services sold on TradingMate.com.au to you;
- (d) to personalize and customize your experiences on TradingMate.com.au;
- (e) to help us research the needs of our customers, and to gain a better understanding of your needs and the needs of customers generally;

- (f) to conduct research for the purposes of improving our services, creating new services or updating the services and products on TradingMate.com.au;
- (g) with regard to our electronic newsletter, to allow us to provide advertising material to you regarding us, our clients, and other business partners; and
- (h) if you submit a resume when you apply for an employee position with us but are unsuccessful, to retain your resume on file for a period of 2 months for later consideration if another position becomes available.
- 4.2 We may collect and use your Personal Information for other purposes not listed above. If we do so, we will make it known to you at the time we collect or use your Personal Information.
- 4.3 We will only collect and use your Personal Information in accordance with this Privacy Policy.
- 4.4 If you choose not to provide your Personal Information to us for the purposes set out in this Privacy Policy, we may not be able to undertake certain activities for you such as providing you with products, services or requested information.

5. To whom we disclose your Personal Information

- 5.1 In order to carry out the above purposes, we may disclose your Personal Information to third parties that provide products and services to or through Trading Mate including our partners, suppliers, distributors, financial institutions, our professional advisors, and other parties to whom we are authorized or required by law to disclose information.
- 5.2 We may also disclose your Personal Information to our TradingMate.com.au host or software application providers in certain limited circumstances, for example when TradingMate.com.au experiences a technical problem or to ensure that it operates in an effective and secure manner.
- 5.3 The nature of the Internet means that some of your Personal Information may be transferred, stored, processed or used overseas by us or by third party service providers. This may happen if we outsource certain activities overseas or if transactions, information, services or products have an overseas connection. You consent to the collection, use, storage, and processing of your Personal Information outside of Australia.
- 5.4 In connection with our use of Google Analytics, Personal Information may be disclosed to an entity or entities overseas where Google's servers are located, where it will be stored solely for the purposes described in this Privacy Policy. In these circumstances, you consent to the collection, use, storage and processing of your Personal Information in those countries.

6. Marketing

6.1 By becoming a Trading Mate Member you are automatically subscribed to our electronic newsletter, which contains news and information about new Members, services, special offers and other promotional announcements. As a subscriber to the newsletter, we may use your Personal Information to provide you with marketing material about us, our Members, our services or products that we think may be of interest to you. We do not disclose any personally identifiable information of our users to advertisers except that which you have chosen to disclose during the process of application for a Member account. You can, at any time access and alter the information disclosed within your Member account (business profile) but must always maintain the minimum mandatory items indicated with a star on your initial Business Profile page to retain your Trading Mate Membership.

- 6.2 You may opt-out of receiving our emails, electronic newsletter and marketing information from us at any time by:
- (a) Clicking on the "Unsubscribe" link included in any general email or newsletters you receive from us;
- (b) contacting our Privacy Officer in any of the ways specified in clause 10 of the Privacy Policy.
- 6.3 Unless otherwise specified in this Privacy Policy, we or our TradingMate.com.au host will not disclose any of your Personal Information to any other organization unless the disclosure is required by law or is otherwise permitted by the APPs.

7. Finding out what Personal Information we hold about you

- 7.1 You are entitled to access Personal Information that we hold about you. If you request access to your Personal Information, we will grant your request unless providing you with access would unreasonably impact upon the privacy of others or is not otherwise permitted under the APPs. If we refuse your request to access your Personal Information, we will provide you with reasons for the refusal.
- 7.2 A request for access can be made by contacting our Privacy Officer specified in clause 10 of the Privacy Policy.

8. Updating, storage and security of Personal Information held by us

- 8.1 We aim to keep your Personal Information secure and current. Any Personal Information that is collected via TradingMate.com.au or which is held on our computer systems is protected by safeguards including physical, technical (e.g. firewalls, SSL encryptions) and procedural methods.
- 8.2 Personal Information that is held by us in hard copy is stored securely on our premises and is only disclosed or used for the purposes described in this Privacy Policy.
- 8.3 You can update your contact and Personal Information at any time on TradingMate.com.au through the "Business Profile" functionality in your account. If we find that we have no further need for your Personal Information we may remove it from our systems and destroy all record of it. We welcome notification from you of any changes to your details so as to keep our records up to date.
- 8.4 All and any Personal Information collected by Trading Mate is only handled by those with authorised access. Personal Information we collect is not disclosed to any third parties for any purposes which would result in misuse.
- 8.5 Credit card details and financial information is not stored by Trading Mate on any platform or via any method whatsoever. Renewal options, where access to your previous financial details are used to charge the agreed amount to your previous credit card account, are accessed via the eWay gateway payment system through TOKEN API ID. Trading Mate has no direct or indirect access to this information and warrants to always ensure the method of transfer of such financial information is protected via the SSL (Secure Socket Layer) certification, noted by the padlock symbol in the www.eway.com.au/about-eway/technology-security/

9. International Use and your Personal Information

We make no representation or warranty that your Personal Information will be collected, held and used by us other than in accordance with APPs set out in the Privacy Act 1988 (Cth). If you choose to

access TradingMate.com.au from locations outside of Australia, you do so at your own risk and such access will be subject to the laws of Australia.
